The Cosmetology, Manicuring and Instructor curriculums are designed to provide competency-based knowledge and hands-on training through theory instruction and a simulated salon and school environment. Each curriculum is designed to give the student the skills necessary to transition easily from the school environment into the work field. Upon completion of the required courses and the requirements of the NC State Board of Cosmetic Arts, graduates are qualified to apply to be tested and licensed by the board.

JOB OPPORTUNITIES

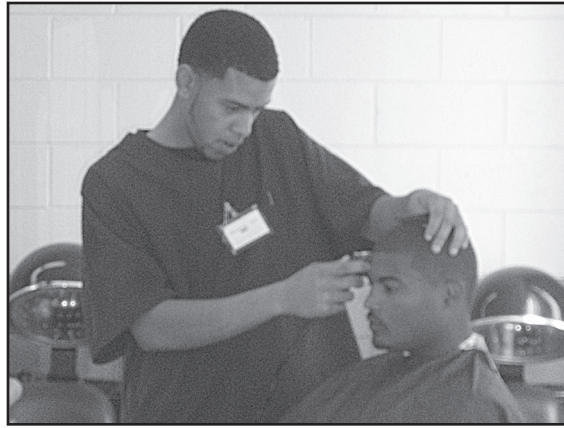
