LPN TO ADN TRANSITION PROGRAM

ADMISSIONS REQUIREMENTS SPRING ADMISSION

MISSION STATEMENT

The LPN to ADN Transition program supports the mission of the North Carolina Community College System and the mission of Vance-Granville Community College (VGCC). The faculty is committed to providing accessible high-quality nursing education to meet the diverse and changing healthcare needs of the service area and to promoting the development of qualified students prepared for the professional role of registered nurse at the entry level. Graduates of this program meet the educational requirements to take the National Council Licensure Examination (NCLEX-RN®).

ADMISSION PROCEDURES

Students are admitted to the LPN to ADN Transition program (A45110L) in accordance with policies set by VGCC. Each applicant is required to meet the minimum admission eligibility requirements as set by the College. Meeting minimum eligibility requirements does not guarantee admission into the program, only an opportunity for consideration. Completion of the VGCC LPN to ADN Transition program does not guarantee success in passing the National Council Licensure Exam (NCLEX®).

The selection process for this program includes PROGRAM APPLICATION PROCESS Completion (must be completed for consideration for the LPN to ADN Transition Program), Points Allocation, and Acceptance Status. Regulations, procedures, and course requirements are subject to change as necessary and without prior notice.

NOTE: This program is offered at the Main Campus in Henderson.

STEPS FOR PROGRAM APPLICATION

1. Apply to VGCC. Designate LPN to ADN Transition program as the desired program of study. Deadline for the online application to VGCC for the Spring Admission to the LPN to ADN Transition Program is 11:59 p.m. on the last business day in September. Applicants will be placed into a Pre-Health Curriculum (Associate in General Education-General Science A10300S), until selected into the program. Submit official transcripts. Students must be eligible to enroll in ENG 111 and MAT 143 without a pre-requisite or co- requisite course in order to be eligible for admission into the desired Nursing program.

Test scores or developmental coursework must be completed within 10 years of the PROGRAM APPLICATION PROCESS deadline.

Meet with an Academic Advisor - Nursing. Please see the specific nursing program website for contact information.

The following items are required as part of the PROGRAM APPLICATION PROCESS:

A. Completion of an LPN diploma program with official transcripts sent to VGCC to verify completion.

- B. Current listing on the North Carolina Board of Nursing website with an unencumbered LPN license.
- C. Current work experience as an LPN of 3 months or greater.
- D. A cumulative GPA of 2.8 or higher. A grade of "C" or better is required for all general education courses. BIO course(s) required for the program must be completed within 10 years of the PROGRAM APPLICATION deadline.
- E. BIO 271 <u>OR</u> BIO 168 and BIO 169 must be completed with a "C" or better before beginning the program. ENG 111 must be completed with a "C" or better before beginning the program.
- F. Completion of the ATI Proctored Fundamentals Test with a minimum score of Level 1 or higher. Scores may be transferred in from other schools. Students may take up to three times as necessary to achieve the desired score. Students who score less than Level 2 should utilize the ATI report of their assessment and remediate areas of needed improvement.
- 3. The PROGRAM APPLICATION PROCESS must be completed by 5 p.m. on the last business day in October. If the last business day in October is a holiday, the deadline will be the business day before the holiday.

ADMISSION POINTS ALLOCATION

A points allocation formula will be used to rank students for admission utilizing completion of one approved additional healthcare program and general education course grades. The students with the highest ranking will be eligible for admission. If there is a tie in total points, students will be accepted in the order of their completed PROGRAM APPLICATION PROCESS to the LPN to ADN Transition program.

The following items will be utilized to calculate points toward selection into the program:

1. Points for course performance/completion will be awarded as follows:

 - ** Required course to be taken prior to admission to the program. A grade of "C" or higher is required per BIO course. BIO course(s) required for the program must be completed within 10 years of the PROGRAM APPLICATION PROCESS deadline.
- 10 points will be awarded for documentation of completion of one approved additional and current healthcare certification/licensure. Students must provide proof of current certification. Students with more than one healthcare certification will only be awarded points once.

Approved certifications: Paramedic, Medical Assistant, Pharmacy Technician, CNA I or II, or Radiologic Technologist

3. Attendance at Mandatory Information Session. Information related to dates of sessions can be found on the Program Webpage starting on October 1st of each admission cycle.

Students will be notified of acceptance or selection as an alternate beginning by the last week in November.

Health insurance is required for this program. Failure to demonstrate proof of health insurance by the start of the program will result in loss of enrollment.
